End of 9th Grade

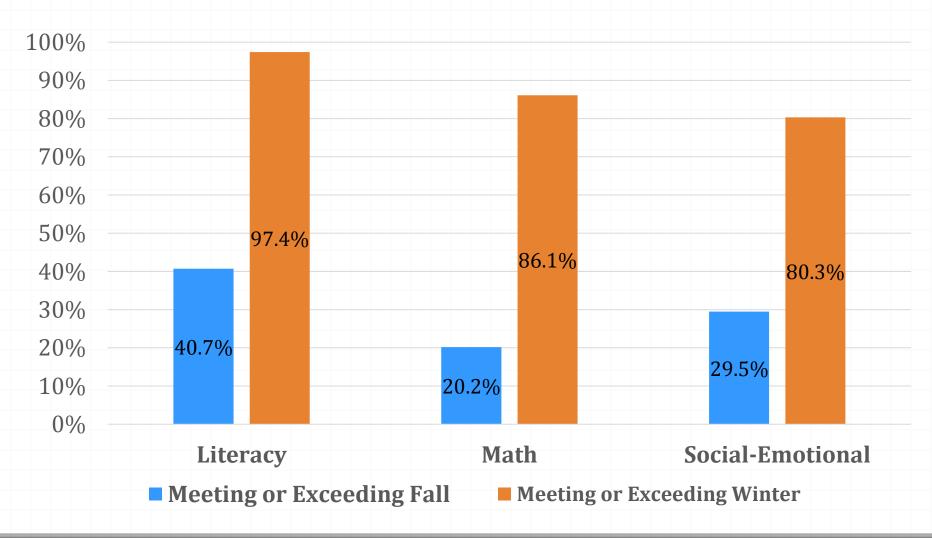
• 8 credits earned

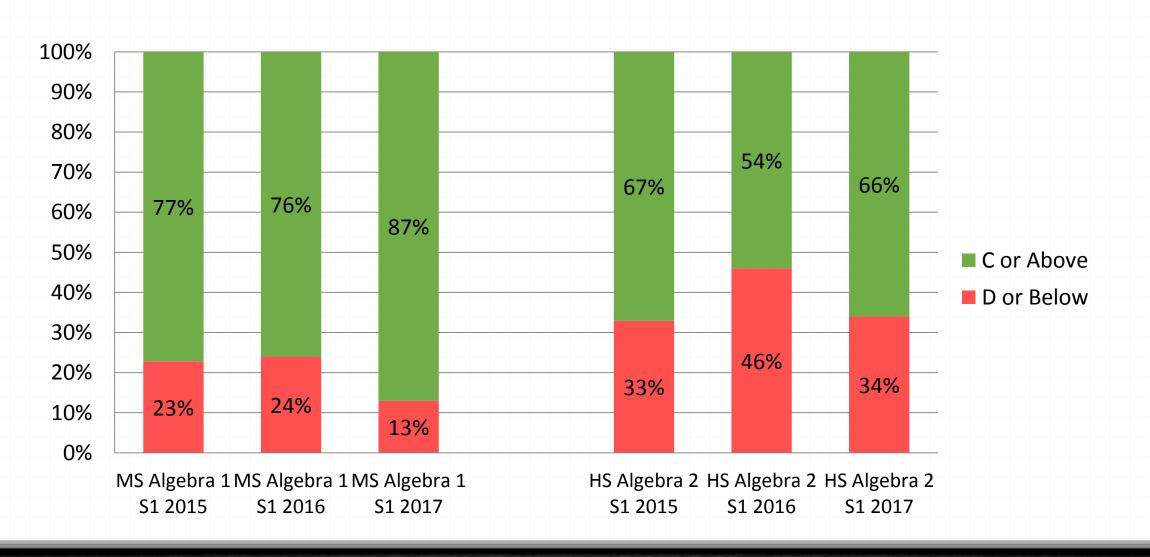

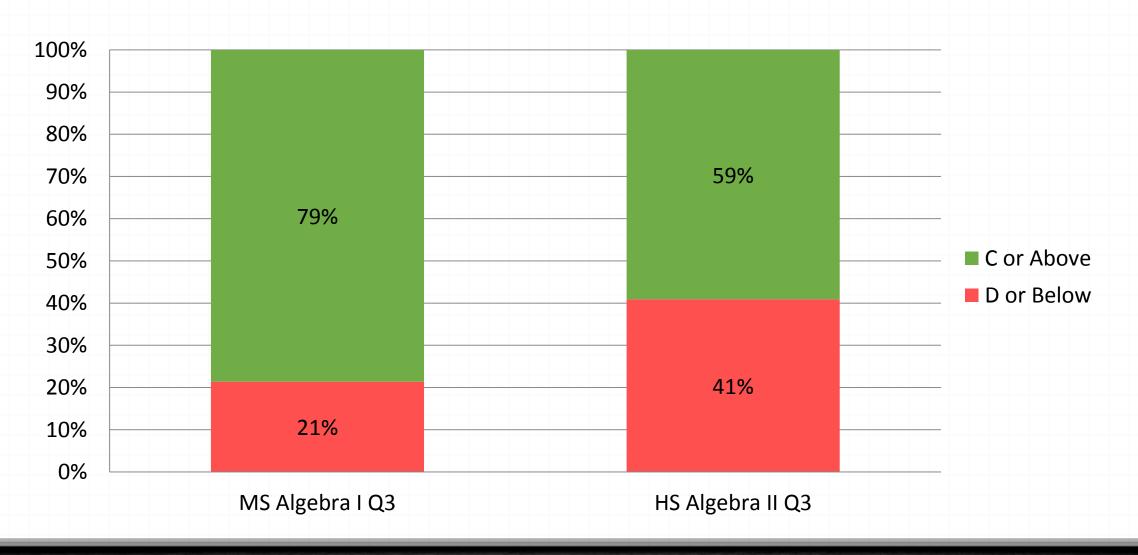

Strategy 4: Creative Independence Bright Spots

- FAFSA completion rate as of May 5 = 50.7% (State average = 47.7)
- Bulldog Robotic Team who won first place & the Team Spirit Award out of 28 teams at the FIRST Robotics PNW Regional competition

- MVHS Construction students competed in the Tiny House Showcase of Skills in Olympia
