Organization of the School Board

The Board consists of five citizens of the School District, residing in five director districts, each of whom is elected for a 4-year term. Each director is elected by and represents all citizens of the School District. Members, by choice, serve without pay. A president and vice president are elected annually, and the legislative representative is elected every two years. Student Advisors to the Board serve as a communication link with the student body.

Role of the School Board

The Mount Vernon School Board is legally responsible to the state for the governance of the District. The Board conducts the business of the District at its regular and special meetings.

Responsibilities of the School Board include:

- Advocating on behalf of students and their education
- Establishing the School District's vision and mission
- Selecting and employing the Superintendent
- Determining the instructional program
- Approving and monitoring annual budgets
- Determining and providing for facility and equipment needs

School Board Meetings

Regular meetings of the Board are held in the various schools throughout the District and on zoom on the first and third Wednesday of each month at 6:00 p.m. Meeting agendas are available in the Superintendent's Office at 124 East Lawrence Street or online at www.mountvernonschools.org. Informal and special meetings, as well as work sessions, are also held throughout the year to give the Board the opportunity to consider a specific topic. Public notice is provided through the news media and on the District's web site (www.mountvernonschools.org).

All regular, informal, and special meetings are open to the public. The Board may choose to meet in executive session to discuss such matters as evaluating the qualifications of an applicant for public employment or reviewing the performance of a public employee, discussing the sale or purchase of property, and discussing possible litigation. Formal actions occur in public session.

Your Participation is Invited

As an elected body, the School Board can best represent you when you make your interests and opinions known. The Board encourages you to become involved in school activities at the building level, citizens' advisory committees at the District level, and attendance at School Board meetings.

Visitors are welcome at Board meetings. If you know in advance that you would like to address the Board at a meeting, you may call the Superintendent's Office at 360-428-6181. Questions and concerns presented to the Board will typically be investigated and addressed by the Superintendent or his/her designee as soon after the meeting as possible.

In the interest of personal privacy and fairness, verbal comments during a School Board meeting regarding individual employees of the School District are not allowed. An executive session may be granted for consideration of such matters. Questions or comments concerning instructional practices or instructional materials should be directed to the Superintendent.


